- A. On motion by Mr. Anderson and seconded by Mr. Grosh, the board voted 7-0 to recommend approval that Dr. Robin Felty be elected to the position of Superintendent of Manheim Township School District, on or about July 1, 2016 and ending on June 30, 2020, at an annualized salary of \$160,000 for the 2016-17 school year.
- B. On motion by Mr. DeLeo and seconded by Mr. Grosh, the board voted 7-0 to recommend to enter into a contract with Martin J. Hudacs Consulting, LLC to provide professional guidance and assistance to the Manheim Township School District in the transition of Superintendent Robin Felty. The compensation to be paid to Martin J. Hudacs Consulting, LLC shall be a per diem rate of \$700 per day or \$350 per half day, up to a maximum of 30 days. The use of the consulting services shall be at the discretion of Superintendent Felty and/or President of the Board of School Directors.
