Subject:	Approval of lease with Apple Financial Services for the purchase of iPads for all professional staff and students in grades 3, 5, 7 and 9 – 12.

Summary:	<p>As presented to the School Board in December, the next step for implementation of our technology initiative is the purchase of iPads for all professional staff this month followed up with the purchase of iPads for all students in grades 3, 5, 7 and 9-12 in May 2017. Apple has a financing option available to fund this purchase over a 3 /12 year period with 0% financing. In addition, Apple has provided additional services at no cost.</p> <p>We will purchase the following (the exact quantities could vary slightly based on teaching staff and student enrollment):</p> <ul style="list-style-type: none">• iPads for staff and students as listed on the attached schedules• 3,750 STM Dux Plus cases - one for each student iPad• 4,250 Jamf Casper licenses - one for each iPad. This is the software that manages the iPad, distributes software, provides a live inventory report, etc. <p>The proposed timeline is:</p> <ul style="list-style-type: none">• January - purchase 500 staff iPads and Jamf licenses. Total cost = \$329,500.00.• March - begin deploying staff iPads• May - purchase 3,750 student iPads and Jamf licenses. Receive access to Apple’s free services. Total cost = \$2,591,062.50.• Summer - begin using Apple’s Professional Learning services• Fall - begin deploying 3,750 student iPads <p>Apple will provide the following at no cost:</p> <ul style="list-style-type: none">• 20 days of Apple Professional Learning (staff development days) - \$58,000 value• Project Management Deployment Services (assist in developing smooth deployment procedures) - \$8,500 value• Project Engineering Services (one year of engineering support) - \$14,620 value <p>The proposed lease payment schedules are:</p> <ul style="list-style-type: none">• January/February, 2017 - \$109,833.33 (staff iPads)• May, 2017 - \$600,000 (student iPads)• 2017-2018 - \$773,520.83 (staff & student iPads)• 2018-2019 - \$773,520.83 (staff & student iPads)• 2019-2020 - \$663,687.50 (last payment for student iPads)
