



2019-2020 MTSD Optional iPad Protection Plan

Dear Parent/Guardian:

The Manheim Township School District offers each student the opportunity to protect district-owned iPads issued to students as part of the 1:1 Mobile Learning Initiative. Prior to purchasing an Optional iPad Protection Plan, please read through the Student iPad Handbook to understand the responsibilities in the care and use of the iPad. This optional plan protects the iPad against accidental damage (drops/spills). This protection plan will assist with replacement cost coverage and protect the iPad on and off school grounds.

MTSD iPad Protection Plan

- **Non-Refundable Yearly Fee: \$10.00** per child
- **Limits of Liability:**
 - The Protection Plan can be used for two separate incidents of damage with a total coverage of \$300.00. Restated, the Plan expires after two incidents or \$300 of coverage, whichever comes first.
 - Three or more incidents of damage are completely the responsibility of the student/guardian. A second protection plan may not be purchased in a single school year.
 - **Example:** A student damages an iPad that requires \$150 of repairs; the student would not be responsible for any costs at that time, and the student would have \$150 of coverage remaining. The same student damages his/her iPad a second time that requires \$200 of repairs. This would exceed the remaining coverage available by \$50 which would need to be paid by the student/guardian. The student would have no coverage available for the remainder of the year.

Charger Cable	\$19.00
Case	\$60.00

Effective Date of Coverage

*MTSD Optional iPad Protection Plan must be purchased within **7 days** of receipt of iPad. Protection begins upon receipt of iPad Protection Plan payment and ends on the last student day, 2020 or upon disenrollment at MTSD, whichever comes first.*

COVERAGE AND EXCLUSIONS

iPad Protection Coverage



Accidental Damage: Pays for accidental damage caused by liquid spills, drops, cracked or broken screen, or any other unintentional event.

Students/Parents are always financially responsible for:



Damage caused to the iPad if the MTSD issued case is not in place.



Damage caused by intentional misuse and/or abuse, or intentional cosmetic damage.



Dishonest, fraudulent, intentional, negligent (not locked/stored in a secured manner or location) or criminal actions.



“Jailbreaking” or otherwise voiding the manufacturer’s warranty by altering the software.



Any lost or unreturned item (iPad, case, charger, cable).



Three or more incidents of accidental damage or excess of \$300 of damage.

Students/Parents are not financially responsible for:



Theft: A theft claim **requires** a report to be filed with the police and shared with MTSD.



Fire: An official fire report must accompany the claim from the investigating authority.
