

MANHEIM TOWNSHIP AGE GROUP SWIM PROGRAM
2019-2020 SEASON

Eligibility: Residents of the Manheim Township School District in the first through ninth grade (6-14 years of age) who are not currently enrolled in a YMCA or USS swim program. **Children of MT faculty members residing outside the school district are also eligible to register.** Participants must be able to swim the length of the MTHS pool in both Freestyle and Backstroke. Eligibility requirements also include participation in **THREE** of the six scheduled dual meets.

Ninth Graders: Ninth graders who have not attained the age of 15 before December 01, 2019 are eligible to compete. There is no registration fee for eligible ninth graders. Ninth graders will practice with the high school team and will be charged \$50.00 to cover entry fees and bus transportation.

Program Fee: \$325.00 (covers registration, bus transportation, and entry fees)

Season: Monday, Nov. 11, 2019 – Saturday, Feb. 22, 2020

Practice Schedule: Swimmers will be divided into 3 practice groups based on the age criteria listed below. Swimmers may come to as many practices as they choose but are limited to the practice times established for their respective ages.
