# Superintendent's Letter

It is with great pleasure that we bring you the 2021-2022 Annual Report for the Manheim Township School District (MTSD). As we worked to create this year's Annual Report, which serves as a reflection of our accomplishments from last school year, it became clear how strongly our district was positioned through the challenges of last year's pandemic. Both our students and staff put forth such great effort in the learning process and school/district operations; the information in this report is a testament to their dedication and strength. The district's strong positioning last year carried us successfully into this current school year.

With last year's comprehensive mitigation measures, we were able to provide in-person learning from the start of the school year. In this school year, with many of the same mitigation efforts still in place, we are able to continue focusing on the provision of effective in-person learning. Additional supports are offered to students transitioning back to in-person learning from a previous remote/virtual learning environment, as needed. At this time, approximately 98% of our student population is receiving in-person learning in our schools; approximately 2% is enrolled in our Manheim Township Virtual Academy (MTVA).

This 2021-2022 Annual Report holds information about our district initiatives and projects, academic and extracurricular programs, notable achievements, and upcoming events. One of the key initiatives this year involves the development of a new Comprehensive (Strategic) Plan for all nine schools and the district. We are at the midpoint of the six-

year comprehensive planning process outlined by the Pennsylvania Department of Education, which requires the creation of updated Comprehensive Plans that hold new goals, strategies, and action plans that span the next three school years.

An important part of the comprehensive planning process is the review of the district's efforts around equity and inclusion. The district has implemented North Star leadership that provides direction and a clear purpose in the planning for equity and inclusion — "Creating an inclusive learning environment where all students and staff feel a sense of belonging." Our North Star aligns nicely with the district mission statement – "Nurture and challenge for success." The collective work to make meaningful progress toward our North Star involves the efforts of the various Diversity, Equity, and Inclusion (DEI) teams within the district. Each of our nine schools has a DEI team comprised of parents, staff, and administrators. The secondary-level DEI teams also include students. The district-level DEI committee includes parents, students, administrators, and community members. All of these individuals will be involved in the development of the new Comprehensive Plans. These plans are due to the Pennsylvania Department of Education by March 30, 2022.

This year, we are also continuing our work on several multi-year initiatives:

- Social-Emotional Learning (SEL) and Mental Health Supports
- Multi-Tiered System of Supports (MTSS) framework, which provides students with

levels (or tiers) of supports for learning

- Early Language and Literacy Development
- Student Voice and Leadership
- "Life Ready Graduates" (prepares high school students for career readiness that aligns with the Career Ready Lancaster! Program, a career pathways partnership that links people to their career through the collaboration of education, business, and community groups, thereby developing a quality workforce for a strong local economy)

The work to create "Life Ready Graduates" provides students with important employability skills that ultimately improve academic achievement, promote college and career readiness, and increase graduation rates. Needless to say, we have exciting initiatives occurring at all levels throughout our district this school year. To paraphrase a statement by Theodore Roosevelt (1903), our district is deeply involved in 'work worth doing.'

We thank our families and the Manheim Township community for their dedication to our students, our educational and extracurricular programs, and the school district.





# Manheim Township High School – Skylab

The Manheim Township Educational Foundation (MTEF) was approached by high school Astronomy/Geosciences teacher David Farina and the District Administration in 2017 to discuss exploring the idea of building an outdoor observatory with a retractable roof – a SkyLab. This five-year project required extensive research and planning.

The SkyLab Observatory will ultimately foster a desire to continue learning STEM subjects such as math, physics, astrophysics, astronomy, engineering, and scientific research. This unique learning environment will be used by teachers and students at all grade levels, and holds the ability to interface with classrooms via the internet in order to connect with students simultaneously. The setup, alignment, and take-down time will be virtually nonexistent in the facility, thereby providing students with more time to devote to their research and skill-building.

Students in the physics and astronomy classes, STEM Independent Study, and MT Astronomy Club will be taught to run visual observations and host star watches for the community at large. Through these opportunities, they will have hands-on learning experiences that build their technical knowledge and leadership skills.


Executive Director of MTEF, Jenny Germann, says "They [Foundation] have never before had an opportunity to place students in a real-world outdoor research laboratory on campus that has the potential to allow for real scientific work to be conducted from start to finish. In this observatory, students would quite literally have the universe at their fingertips."

The ability to have these innovative educational experiences at the K-12 level is unparalleled at the local/state level. Very few examples exist on a national level that would rival this level of commitment to STEAM learning. Students and staff are excited to officially begin learning in the facility this school year.

# Curriculum & Instruction Information

# International Baccalaureate (IB)

Manheim Township juniors and seniors have the opportunity to earn an internationally recognized diploma and college credit while in high school, and gives our students another advantage in the college admissions process. The IB curriculum emphasizes an interdisciplinary, student-centered approach to learning with an emphasis on developing critical thinking skills.

2020-2021 was the ninth year that Manheim Township students had the opportunity to earn the IB diploma. Students apply to the IB program in the fall of their sophomore year. For more information about the program, contact Larry Penner, IB Coordinator, at pennerla@mtwp.net.

# **Spanish Immersion Program**

The Manheim Township Spanish Immersion program is a district program that immerses students in Spanish while they learn the same MT curriculum based on the PA Standards. At the elementary level (grades 1-4), selected students from each of our six elementary schools learn Reading, Writing, Spelling, Mathematics, Science, Health, and Social Studies in Spanish. As the Spanish Immersion students transition to Landis Run Intermediate, Spanish is incorporated into homeroom, literacy (reading and writing activities), and intervention/enrichment. In grades 7 and 8, students have one period of Spanish daily that focuses on academic language preparation, with speaking, listening, writing, and reading at a high level of proficiency. In grades 9-12, Spanish may be scheduled as an elective for all immersion students.

# Manheim Township Virtual Academy (MTVA)

The Manheim Township Virtual Academy (MTVA) offers K-12 virtual learning opportunities for Manheim Township families. The MTVA is a collaborative effort with Lancaster-Lebanon Virtual Solutions that provides new learning options for students. Through our participation in the largest consortium of online learning in Pennsylvania, students have access to over 300 courses, traditional and advanced coursework. Our web-based courses meet the increasing demand for high-quality student instruction in a flexible learning environment.

Students can enjoy the flexibility of online instruction as well as participation in extracurricular activities within MTSD and our neighborhood schools!

Enrollment in MTVA provides students the opportunity to maintain active status in MT schools, receive quality online instruction, and participate in all school-related activities. The program offers an academic curriculum with rigorous learning standards and the ability for students to have flexibility in accessing the courses.

# **Multi-tiered System** of Supports (MTSS)

MTSD is currently building a K-12 Multi-tiered System of Supports framework (MTSS). MTSS is a prevention framework that organizes building-level resources to address each individual student's academic and/or behavioral needs within intervention tiers that vary in intensity. MTSS allows for the early identification of learning and behavioral challenges and timely intervention for students who are at risk for poor learning outcomes. The increasingly intense tiers (i.e., Tier 1, Tier 2, Tier 3) represent a continuum of supports.

# MTSD's Assessment Framework & Guidelines

MTSD's Assessment Framework & Guidelines support MTSS as equity and consistency in assessment practices are crucial. The Assessment Framework & Guidelines ensure that all students are assessed accurately, fairly, and consistently. The guidelines are designed to ensure that assigned grades reflect student achievement of the standards and concepts outlined in the curriculum.

## New Elementary (K-4) Report Card Slated for 2022-2023 School Year

The district is currently developing a new K-4 elementary report card for the 2022-2023 school year. The Elementary (K-4) Standards-Based Report Card will specifically communicate to parents and students what skills have been mastered. Each student's achievement will reflect the district's standards-aligned ELA (English Language Arts) and Math curriculum, based on the Pennsylvania Standards ( https://www.pdesas.org ). In addition to reporting academic performance, the revised report card will also reflect the district's commitment to educating the whole child. Through Morning Meetings and other opportunities throughout the day, students receive direct instruction in grade-appropriate ways to practice and demonstrate respect, responsibility, and safety. The "learner behaviors rubric" on the report card will allow teachers to communicate each student's use of these three key skills.



# Manheim Township Middle School Update





After a multi-year effort toward building a new Manheim Township Middle School (MTMS), we were beyond excited to welcome our students this school year to a 21st-century learning environment that truly captures the essence of a Blue Streak! When asked what they liked most about the new building, Principal Christine Resh and Assistant Principal Andrew Hull shared their appreciation for "the classrooms [that] are designed to meet the instructional needs of specific curriculums."


Once you walk into the building, it truly feels like you have stepped into an innovative learning space that engages the interactive, collaborative nature of middle school students. When several of our 7th and 8th grade students were asked about their favorite features of the new school, they shared their pleasure with "the movable furniture in the breakout spaces, the blackbox theater [that] is nicely designed, and the beautiful library." They also added that the new middle school "is easier to navigate."

MTMS teacher Shawn Robbins provided his thoughts about the new school: "When staff walked into the new building for the first time, I can honestly say the wait was worth it. Students have so much more space to collaborate with their classmates in the breakout spaces, and they have bathrooms closer to their classrooms. The teaching staff also enjoy having windows that open and bathrooms in close proximity to our pods. Students really have a lot of what they need in their team pods." The concept of "team pods" was thoughtfully incorporated into the design structure of the building and allows for greater student and teacher collaboration.

# Transportation

Approximately 6,600 children who reside in the Manheim Township footprint are transported to and from school every day. Students are bused to our nine Manheim Township school buildings, and as per Pennsylvania law, are also transported to (26) non-public schools, (1) Charter School and (6) Special Education program locations. Brightbill Transportation, the bus contractor for the district, employs over 54 bus drivers and 14 van drivers. Other bus contractors are also utilized for special situations.

Radios on the buses permit the Brightbill Transportation dispatcher and school personnel to communicate directly with drivers. Cameras assist the driver and school personnel in promoting safety for students on the buses.

Our buses travel approximately 680,000 miles annually to transport students to/from school, field trips, athletic trips, and activity runs.



More than 334,700 school lunches and 79,000 school breakfasts are served annually in our nine schools by a dedicated and well-trained staff of over 50 full- and part-time employees in our Food Services Department.

Over the past year, our Food Services
Department provided meal menus with
healthier choices at all grade levels.
Current school meals include more whole
grains, additional fiber, lower sodium
content, and a decrease in added sugars.
Nutritional guidelines and federal nutrition
regulations, which limit the fat content,
sugar content, and portion size of foods
served, are implemented throughout
Manheim Township School District.

For the past few years, we have received a grant to provide a free summer lunch program for students. This summer lunch program has been quite popular; this past summer (2021), it offered a total of 31,970 meals to students! Given the ongoing interest, we hope to continue offering a summer lunch program.

# Annual Public Notice of Special Education Services and Programs, Services for Gifted Students, and Services for Protected Handicapped Students

State and federal special education regulations require each school district to provide notice to the community by publishing an annual public notice to parents, in newspapers, on the website, or by other media, regarding the school district's identification and screening activities, the location and time of the activities, and also any evaluation activity that takes place in the Manheim Township School District.

The district is required to provide a free appropriate public education (FAPE) to children with disabilities who are determined, through the evaluation process, to need special education and related services under IDEA and 22 PA School Code Chapter 14. A school-age child with a disability, who is determined to be in need of special education and related services, is identified as a child with a disability for special education in need of specially designed instruction. The following are disability categories under IDEA:

Autism, Deafness, Hearing Impairment, Multiple Disabilities, Other Health Impairment, Traumatic Brain Injury, Specific Learning Disability, Speech or Language Impairment, Deaf-Blindness, Emotional Disturbance, Intellectual Disability, Orthopedic Impairment, Visual Impairment

Early Intervention: Children ages 3 through the age of admission to first grade are also eligible if they have developmental delays and, as a result, need special education and related services. Developmental delay is defined as a child who is less than the age of beginners and at least 3 years of age and is considered to have a developmental delay when one of the following exists: (i) The child's score, on a developmental assessment device, on an assessment instrument that yields a score in months, indicates that the child is delayed by 25% of the child's chronological age in one or more developmental areas. (ii) The child is delayed in one or more of the developmental areas, as documented by test performance of 1.5 standard deviations below the mean on standardized tests. Developmental areas include cognitive, communicative, physical, social/emotional and self-help. Screening Activities: The Manheim Township School District conducts ongoing screening activities throughout the school year to identify students who may have a disability and be in need of special education services. Screening is conducted in the student's home school unless other arrangements are necessary. If a child is identified by the district as possibly in need of such services, the school district will seek parental consent to conduct an evaluation. Parents can request screening in writing for their children by contacting the building principal.

**Evaluation Process:** When screening indicates that a student may have a disability, the school district will seek parental consent to conduct an evaluation. "Evaluation" is the procedure used to determine whether a child has a disability and if the child's disability is of the nature and extent that the child would be eligible for special education and related services. Evaluation procedures used are determined on an individual basis by a Multi-disciplinary Team, which includes the parents. Evaluation for the purpose of determining if a child has a disability eligible for special education does not include the procedures or basic tests that are administered to all children.

Parents who think their child is exceptional may request, at any time, that the school district conduct an evaluation. This request should be made in writing to the building principal. If a parent makes an oral request for an evaluation, the school district shall provide the parent with a form for that purpose within 10 days of the oral request.

Independent Educational Evaluation: Parents also have the right to obtain an independent educational evaluation. The school district must provide to parents, on request, information about where an independent educational evaluation may be obtained and criteria application for independent evaluations. Under certain circumstances, such an independent educational evaluation may be obtained at public expense.

**Consent:** School entities cannot proceed with an evaluation or with the initial provision of special education and related services without the written consent of the parents. For additional information related to consent, please refer to the Procedural Safeguards Notice, which can be found at the

PaTTAN website, www.pattan.net/. Once written parental consent is obtained, the district will proceed with the evaluation process. If the parent disagrees with the evaluation, the parent can request an independent education evaluation at public expense.

**Program Development:** Once the evaluation process is completed, a team of qualified professionals and parents determine whether the child is eligible. If the child is eligible, the Individualized Education Program (IEP) team meets, develops the program, and determines the educational placement. Once the IEP team develops the program and determines the educational placement, school district staff, intermediate unit staff, or charter school staff will issue a Notice of Recommended Educational Placement/ Prior Written Notice (NOREP/PRN). Your written consent is required before initial services can be provided. The parent has the right to revoke consent after initial placement.

**Gifted Education:** The Manheim Township School District conducts child find activities for children who may be eligible for gifted services via 22 Pa. School Code Chapter 16. Parents who suspect that their child is in need of specially designed instruction beyond that required in 22 Pa. School Code §16.22. If a student is both gifted and eligible for special education, the procedures in IDEA and Chapter 14 shall take precedence. For additional information, please contact the Director of Pupil Services at 717-569-8231.

Protected Handicapped Students: In compliance with state and federal law, and 22 Pa. School Code Chapter 15, the Manheim Township School District will provide to each protected handicapped student, without discrimination or cost to the student or family, those related aids, services or accommodations that are needed to provide equal opportunity to participate in and obtain the benefits of the school program and extracurricular activities. In order to qualify as a protected handicapped student, the child must be of school age with a physical or mental disability that substantially limits a major life activity or prohibits participation in or access to an aspect of the school program. These services and protections for "protected handicapped students" are distinct from those applicable to all eligible or exceptional students with disabilities enrolled in special education programs.

For additional information related to Section 504/Chapter 15 services, the parent may refer to Section 504, Chapter 15, and the Basic Education Circular entitled Implementation of Chapter 15. Parents may also contact the building principal to request further information on the rights of parents and children, provision of services, evaluation and screening (including purpose, time and location), and due process procedures.

Confidentiality: The Manheim Township School District, and to some extent the intermediate unit, maintain records concerning children enrolled in the school, including students with disabilities. All records are maintained in the strictest confidentiality. Parental consent, or consent of an eligible child who has reached the age of majority under state law, must be obtained before personally identifiable information is released, except as permitted under the Family Educational Rights and Privacy Act (FERPA). The age of majority in Pennsylvania is 21. Each participating agency must protect the confidentiality of personally identifiable information at collection, storage, disclosure, and destruction states. One official at each participating agency must assume responsibility for ensuring the confidentiality of any personally identifiable information. Each participating agency must maintain, for public inspection, a current listing of the names and positions of those employees within the agency who have access to personally identifiable information. For additional information related to student records, the parent can refer to the Family Educational Rights and Privacy Act (FERPA).

This notice is only a summary of the screening, evaluation, services activities, and rights and protections pertaining to children with disabilities, children thought to be disabled and their parents. For information about these policies and procedures, rights of confidentiality, and access to educational records, or to request an evaluation or screening of a public or private school child, parents should contact the Director of Pupil Services at 717-569-8231.

# **Anti-Bullying and Harassment Policy**

The Manheim Township School District Board of School Directors is committed to providing a safe, positive learning environment for district students. The Board recognizes that bullying and unlawful harassment create an atmosphere of fear and intimidation, detract from the safe environment necessary for student learning, and may lead to more serious violence. Therefore, it shall be the policy of the school district to maintain an educational environment in which **bullying and harassment in any form is not tolerated** (Policy no. 249).

# Mckinney-Vento Act

Students lacking a fixed, regular, or adequate nighttime residence may be eligible for additional educational support through the federal McKinney-Vento Act. For more information on eligibility, please see our website or contact Roseanne Myers at 717-735-3208.

# **Pest Management Plan**

The Manheim Township School District abides by the provisions of Act 35/36 2002 of the Commonwealth of Pennsylvania – Integrated Pest Management. In accordance with this plan, non-chemical pest management treatment will be implemented whenever practical. Advance notification of pesticide treatment will be posted prior to all applications. Parents or guardians may also request individual notification prior to pesticide use within the school district by contacting the Plant Services Department. All reports of inspections and our management plan are on file in the Plant Services Office located at the District Office. Anyone interested may examine these reports by appointment by contacting the Plant Services Department at 717-560-3080.

# **Asbestos Management Plan**

The Manheim Township Asbestos Management Plan has been approved by the Board of Directors and the Pennsylvania Department of Education. All school buildings are inspected every six months by a third-party consultant and have been found to be in compliance with the rules and regulations of AHERA regarding this subject. All reports of inspections and our management plan are on file in the Plant Services Office located at the District Office. Anyone interested may examine these reports by appointment by contacting the Plant Services Department at 717-560-3080.

# **Notification of Rights under FERPA**

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age ("eligible students") certain rights with respect to the student's education records. They are:

(1) The right to inspect and review the student's education records within 45 days of the day the school receives a request for access. Parents or eligible students should submit to the school principal a written request that identifies the record(s) they wish to inspect. The school principal will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

(2) The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate or misleading. Parents or eligible students may ask the school to amend a record that they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading. If the school decides not to amend the record as requested by the parent or eligible student, the school will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when the school is notified of the request for a hearing.


(3) The right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent. One exception that permits disclosure without consent is disclosure to school officials with legitimate education interests. A school official is a person employed by the school as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the school board; a person or company with whom the school has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

(4) The right to file a complaint with the U.S. Department of Education concerning alleged failures by the school system to comply with the requirements of FERPA. The name and address of the office that administers FERPA is: Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Avenue, SW, Washington, DC 20202.

# **Directory Information Notice**

The school may disclose certain information, known as directory information, in its discretion without consent. Directory information is generally not considered harmful or an invasion of privacy if released. Directory information may be disclosed to entities such as outside organizations that manufacture class rings or publish yearbooks. In addition, two federal laws require schools receiving assistance under the Elementary and Secondary Education Act of 1965 (ESEA) to provide military recruiters, upon request, with three directory information categories – names, addresses and telephone listings – unless parents or students have advised the school that they do not want the student's information disclosed without their prior written consent.

Parents or eligible students may refuse to let the school release any or all of this information. If you do not want this information released, you must send written notice annually to your child's school office before the first day of the school year. The following information regarding students is considered directory information: (1) name, (2) photo, (3) home address, (4) telephone number, (5) date and place of birth, (6) major field of study, (7) participation in officially recognized activities and sports, (8) weight and height of members of athletic teams, (9) dates of attendance, (10) degrees and awards received, and (11) the most recent previous educational agency or institution attended by the student.


